The Heard Museum and Heard Museum Guild comply with the requirements of the **Indian Arts & Crafts Act of 1990 (P.L. 101-644)** which makes it illegal to market an art or craft item in a manner that falsely suggests it is Indian-produced. Under the Act, an Indian is defined as a member of any federally or officially State recognized Indian Tribe, or an individual certified as an Indian by an Indian Tribe. *For information: www.doi.gov/iacb/act*

A first-time applicant must include with this application a copy of his or her tribal enrollment form or Artisan Letter from a Federally or officially State recognized tribe. If you have submitted this information with a previous year's application, you do not need to submit another copy.

Youth Artists

Artists who are 17 years old and under at the time of the Fair and whose relatives have been accepted into the Fair, may sell their work in their relatives' booth and may enter the Youth Artist Show and Sale (see heardguild.org/youth-artist-show-sale for details). - The image files must be in JPG format and no larger than 2 MB (2,000 KB). Submit your images on a CD or DVD with this application. Label the CD or DVD with your name and "IFM 2022." You may also submit images by email to excomm@heardguild.org. Include the same information about your artwork as requested below.
- **The quality of the images you submit is critical:** the better the images, the better your chance of being accepted into the Fair. Please contact us if you have any questions or concerns.
